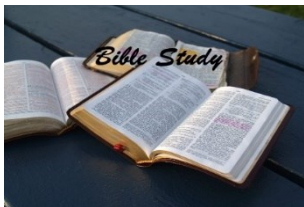

If anyone would like to do the Children's Moment to please let Pastor Murray or the Officer Administrator know of your interest. Thank you.

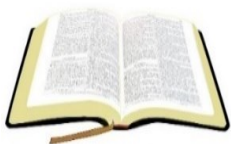
Offering envelopes for 2024 are here and available for pickup either after church or during office hours. If you need other arrangements, please call the church office 570-675-3131.
